

FACTS **WHAT DOES ROUNDPOINT MORTGAGE SERVICING LLC (“ROUNDPOINT”) DO WITH YOUR PERSONAL INFORMATION?**

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some, but not all, sharing. Federal law also requires financial companies to tell you how your personal information is collected, shared, and protected. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> ▪ Social Security number and income ▪ Account balance and transaction history ▪ Credit history and employment information
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers’ personal information; the reasons RoundPoint chooses to share; and whether you can limit this sharing.

Who is providing this notice?	RoundPoint Mortgage Servicing LLC and RoundPoint Mortgage Solutions, LLC (collectively, "RoundPoint").
What we do	
How does RoundPoint protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with Federal law. These measures include computer safeguards and secured files and buildings.
How does RoundPoint collect my personal information?	We collect your personal information, for example, when you: <ul style="list-style-type: none"> ▪ Apply for a loan ▪ Pay your bills ▪ Give us your income information or provide account information ▪ Provide employment information We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only: <ul style="list-style-type: none"> ▪ Sharing for affiliates' everyday business purposes—information about your creditworthiness ▪ Affiliates from using your information to market to you ▪ Sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.
Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> ▪ <i>Our affiliates include companies such as RoundPoint Mortgage Servicing LLC and RoundPoint Mortgage Solutions, LLC; TH MSR Holdings LLC, and Two Harbors Investment Corp..</i>
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. <ul style="list-style-type: none"> ▪ <i>Nonaffiliates we share with can include mortgage companies, insurance companies, securities firms, financial advisors, financial products providers, tax preparers, retailers, direct marketing companies, and nonprofit organizations.</i>
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> ▪ <i>Our joint marketing partners include insurance and other financial companies.</i>

Vermont Customers Only: We will not disclose information about your creditworthiness to our affiliates and will not disclose your personal information, financial information, credit report, or health information to nonaffiliated third parties to market to you, other than as permitted by Vermont law, unless you authorize us to make those disclosures.
